Abstract

Maritime security is a general term which encompasses the protection of vessels both internally and externally. It is essential because it protects an essential element of the global economy. The shipping industry is the engine of the global economy. Annually, it contributes billions USD in gross direct output and millions of jobs. Security threats include piracy and armed robbery, terrorist acts, the illicit trafficking in arms and weapons of mass destruction, the illicit trafficking in narcotics, smuggling and trafficking of persons by sea, illegal, unreported, and unregulated fishing and intentional and unlawful damage to the marine wildlife and environment.

This webinar will cover the incidents & reports for piracy in the West Africa Gulf of Guinea, High Risk Area (Indian Ocean) & Southeast Asia. The speaker will first introduce the trend and different modes of operation for the perpetrators and their intent, motivation, and reason. He will then share on the necessity of having multiple avenues for information as an intelligence network to prepare during any voyage.
